Description of the selected electronic databases:

- CINAHL includes more than 3.4 million records and allows access to standards of practice, health care books and book chapters. It includes clinical trials, full-text journals, research instruments, clinical innovations, legal cases and critical paths. It is easy to use and has basic and advanced search features.
- Cochrane CENTRAL compiles comprehensive reports of randomised and quasi-randomised controlled trials. In addition to Embase and Medline, CENTRAL derives its records from other published and unpublished sources. It does not have restriction on language or date of publication.
- Embase is a database specific for biomedical research, systematic reviews and pharmacovigilance. It contains more than 30 million indices and abstracts from conferences, published, peer-reviewed biomedical literature and press publications.
- Epistemonikos is a multilingual database of evidence that systematically searches electronic databases and other sources for systematic reviews and broad syntheses of reviews.
- Medline is a database that has over 20 million references to journal articles in life sciences, focusing on biomedicine. It contains records that are indexed with NLM Medical Subject Headings.
